- 1. The allottee shall pay all the installments as per schedule of payment agreement between the parties in the agreement to sell.

In case the installment is not received within 90 days from the due date the allotment of shop shall be treated as cancelled and in such case the amount thereof will be refunded to the allottee after the sale of the same shop to another party.
- 3. The demand notice of payments and all other correspondence will be dispatched by post at the address of the allottee/vendee given in the application form. The seller shall not be responsible for non delivery of communications of the allottee / vendee given in the application form. The seller shall not be responsible for non delivery of communications if the allottee / vendee does not notify change of address in advance.
- 4. If the allottee introduces third party into the agreement by way of sale, exchange, gift or otherwise, then such third party shall sign the same terms and conditions of the agreement as the original allottee.
- 5. If for any reason the allottee surrenders the shop to Dubai Shopping Plaza, 20 percent of the total price of the shop, as well as dues, if any, shall be forfeited. The balance amount will be refunded after sale of shop.
