



1. In case of female applicant having no source of income, the particulars of her husband / guardian should be given.

General Terms & Conditions

1. The allottee shall pay all the installments as per schedule of payment agreement between the parties in the agreement to sell.
2. The payment of installment must be paid by the allottee within (30) days from the schedule date. In case the installment is not received within 90 days from the due date the allotment of plot shall be treated as cancelled and in such case the amount thereof will be refunded to the allottee after the sale of the same plot to another party.
3. The demand notice of payments and all other correspondence will be dispatched by post at the address of the allottee/vendee given in the application form. The seller shall not be responsible for non delivery of communications of the allottee / vendee given in the application form. The seller shall not be responsible for non delivery of communications if the allottee /vendee does not notify change of address in advance.
4. If the allottee introduces third party into the agreement by way of sale, exchange, gift or otherwise, then such third party shall sign the same terms and conditions of the agreement as the original allottee.
5. The allottee shall pay the payment of 50% of total payment than start of Work construct at his/her own cost a residential building in conformity with the building regulations by laws of any other regulation authority.
6. The cost payable by the allottee will be adjusted on actual demarcation and measurements of the plot which will be carried out in the presence of the allottee or his / her representative at the time of physical possession of the plot in case the total size of the plot exceeds the standard allotted size, the cost of such additional area shall be payable by the allottee. The same will be applicable incase the size of the plot is less.
7. If for any reason the allottee surrenders the plot to Khawaja Muhammad Khan Town, 10 percent of the total price of the plot, as well as dues, if any, shall be forfeited. The balance amount will be refunded after sale of plot.
8. The allottee shall not disturb / interfere with the layout of the housing scheme in any manner whatsoever and shall not encroach upon and/or usurp or put into his / her name the pathways, roads, green belt, or an other area in the ownership of Khawaja Muhammad Khan Town.
9. The town management has the right to extend the town in any dimension or to utilize its roads and amenities.
10. If the allottee fails to deposit his / her installment, the town management has the right to cancel his allotment after three notices.
11. The town management is selling the plot by square feet.
12. In case of pay order / demand draft / online transaction etc., the name of sender as well as plot No, must be given.
13. The final allotment (Registry) will be issued only on the receipt of total payment and acceptance the aforesaid terms and conditions.
14. If any dispute arises between the allottee and the seller, it shall be first mutually settled and if an amicable settlement cannot be achieved, then both the parties shall accept the decision of an arbiter court.
